



Fund Update for the Britannia Retirement Scheme – Lifetime Income Fund

For the quarter ended 31 March 2018.

This revised Fund Update was first made publicly available on 8 September 2020. It replaces the Fund Update published on 1 May 2018. The change made relates to the investor example.

WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Lifetime Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Britannia Financial Services Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

DESCRIPTION OF THIS FUND

The Lifetime Income Fund turns members' investments into a Retirement Income for the rest of their life. It invests members' money in a diversified portfolio that has a bias towards defensive or income assets and insures their retirement income with Lifetime Income Limited, an insurance company licensed by the RBNZ.

The currency hedging objective for the Lifetime Income Fund is for the entire Fund to be hedged against changes in the value of the New Zealand dollar if there are at least \$2,000,000 of equity investments held in the Fund. While this Fund has a 100% hedging objective, a hedging range of 90% to 100% (once hedging becomes mandatory) will be acceptable and within the limits set by this SIPO.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Lifetime Income Fund*



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

WHAT FEES ARE INVESTORS CHARGED?

Investors in the fund are charged fund charges. Based on the PDS dated 22 March 2018 these are expected to be: ¹

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR?³

Liz had \$10,000 in the Lifetime Income Fund nine months ago and did not make any further contributions. At the end of the nine months, Liz received a return after fund charges and taxes were deducted of \$228 (that is 2.28% of her initial \$10,000). Liz also paid \$90 in insurance charges. This gives Liz a total return after tax of \$138 for the nine months.

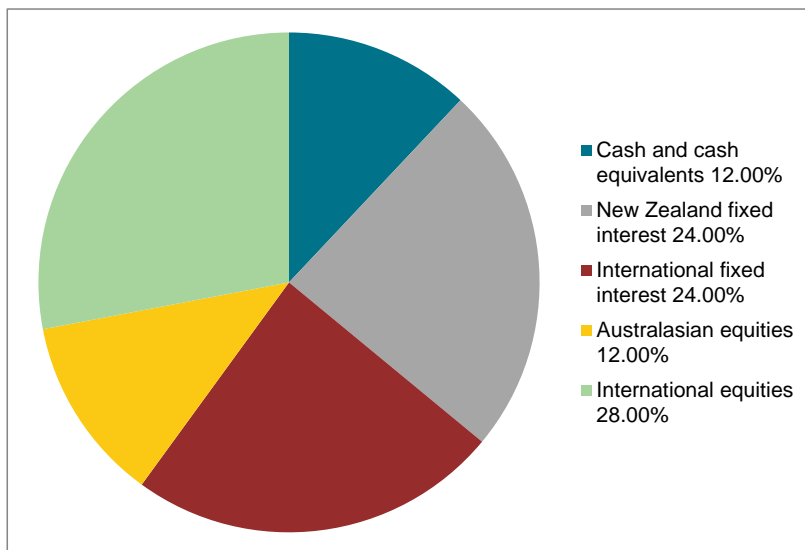
WHAT DOES THE FUND INVEST IN?

NOTES

¹ As the fund commenced on 22 March 2018 fee data described in the PDS was used for the fund charges table.

² Total fund charges are an estimated percentage of the value of your unitholding balance in the fund. This estimate is, in part, based on actual annual fees expected to be paid to underlying fund managers and is also based on anticipated investment levels in the fund. Actual charges may vary from the estimates provided.

Estimated total fund charges are exclusive of GST and are made up of the management fee, the underlying fund managers' fees and other administration fees, which are accrued on a daily basis and reflected in the unit price of the fund. Total fund charges comprise:

- management fees, which are paid to Britannia for the management of the fund's assets;
- underlying managers' fees and expenses (including any performance fees of their underlying funds), which are estimated and paid to the underlying fund managers for their management services; and
- other administration fees, which include the Supervisor's fee, the Custodian's fee, the Administration Manager's fees (for registry, valuation and unit pricing services), the cost of the lifetime income insurance premiums and the estimated accounting expenses of the fund.

The Manager may also charge reasonable auditing and other professional services charges to the fund in the future. Currently the Manager does not charge these fees to the fund, so the estimated fee for these professional services is nil.

The annual fund charge for the fund shown is an estimate only. The actual annual fund charge will be calculated based on two components: 1.15% of each member's investment balance; and 1.20% of each member's Protected Income Base.

³ As the Lifetime Income Fund has only been in existence for a very short period of time and had not received any investment as at the date of this fund update, the figures in the fee example are based on the returns of the Moderate Fund (which has a similar investment strategy) but adjusted for the Lifetime Income Fund's fee structure (which has a lower management fee but also charges an insurance premium). The fee example only covers a nine month period, rather than a full year, because the Moderate Fund has only been invested for that period of time.
