#### **What is the purpose of this update?**

This document tells you how the Global Equities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Britannia Financial Services Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

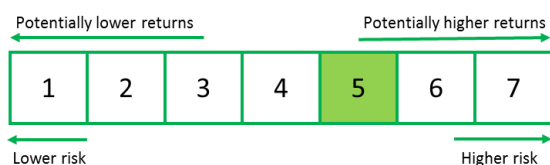
The fund invests in international shares through investment funds operated by our Investment Manager, with a small allocation to cash for operational liquidity. It aims to achieve long-term capital growth through a structured exposure to listed global shares. Investors are exposed to developed and developing economies through an efficient exposure to a highly diversified pool of assets, using both qualitative and quantitative investment techniques.

The fund's exposure to assets denominated in foreign currencies was 98.28%, of which 0% was hedged, and volatility is expected to be high.

#### **What are the risks of investing?**

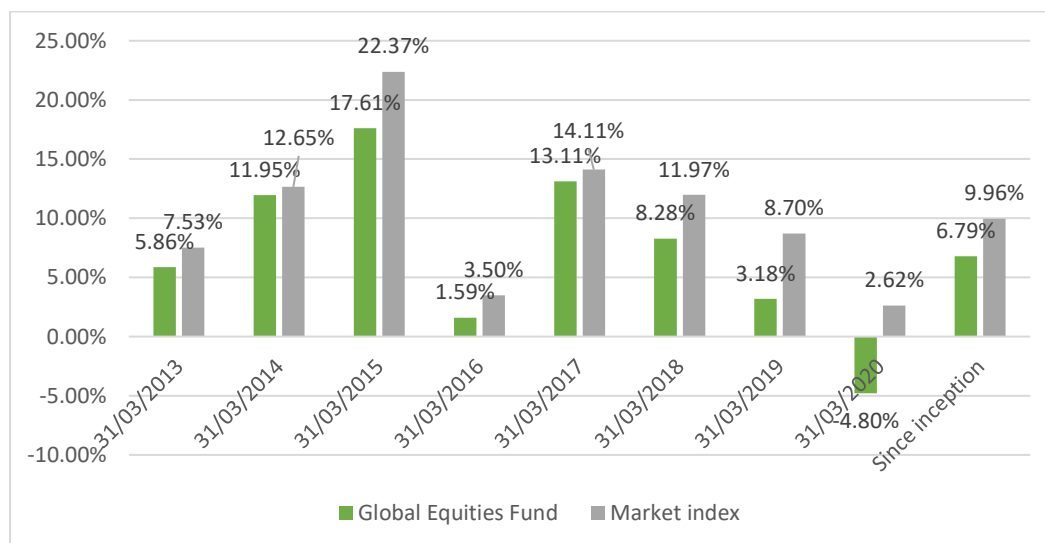

### **Example of how this applies to an investor**

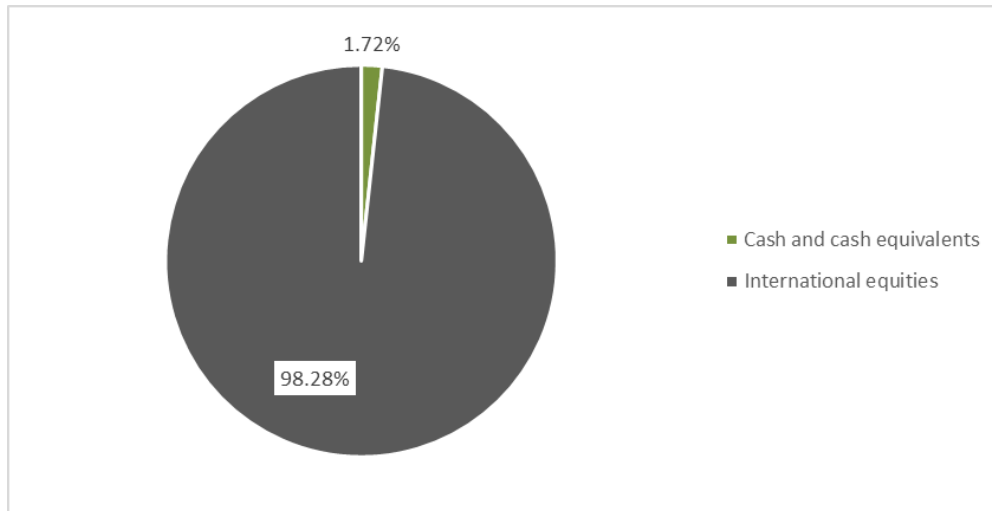
Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Chris incurred a loss after fund charges were deducted of \$266 (that is -2.66% of his initial \$10,000). Chris did not pay any other charges. This gives Chris a total loss after tax of \$371 for the year.

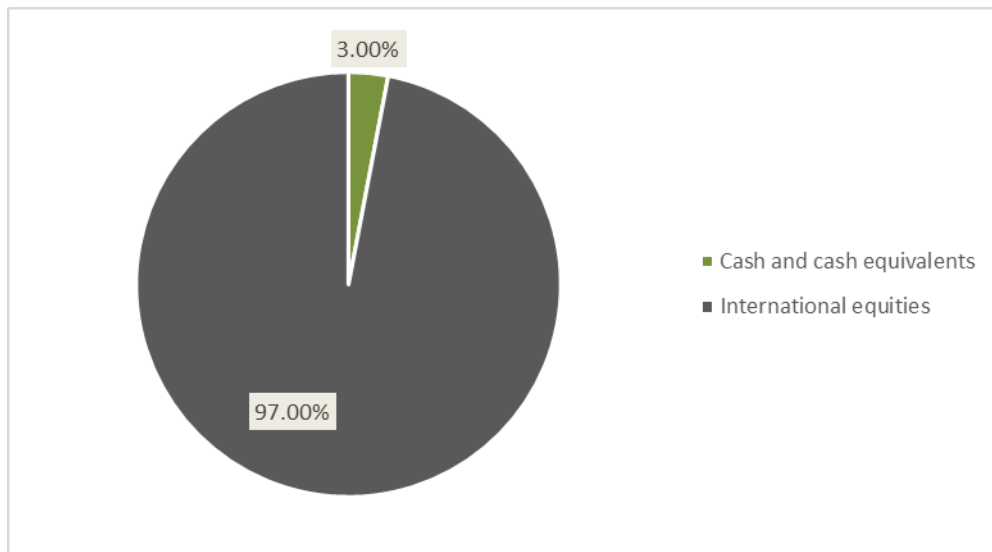

Note 1: The Manager's basic fee is a variable percentage up to 0.65%, and is charged to the investor rather than the Fund.
